**ORDER**

As per the Government Order read as 1st paper above, Government had issued Orders to the effect that all Government Departments, Public Sector Undertakings etc. may purchase their requirement of wooden furniture directly from M/s Kerala Artisans Development Corporation Ltd.(KADCO), Thiruvananthapuram without following tender formalities for a period of one year in relaxation of para 57 (a) (ii) of Stores Purchase Manual. Later Government have extended the period of validity of the said Government Order, from year after year. The last such extended period vide the Government Order read as 2nd paper above expired on 16-1-2009.

The Managing Director, M/s Kerala Artisans Development Corporation Ltd.(KADCO), Thiruvananthapuram as per the letter read as 4th paper above has requested Government to extend the period of validity for relaxation to para 57(a) (ii) of Stores Purchase Manual for a period of two years.

Government have examined the matter in detail and are pleased to extend the period of validity for relaxation to para 57 (a) (ii) of Stores Purchase Manual for a further period of one year from 17-1-2009, subject to the condition that the price of the wooden furniture (Teakwood, Anjili Wood/Hardwood) should be in accordance with the price list approved vide the G.O. read as 3rd paper above.

All Government Departments, Public Sector Undertakings, Local Self Government Institutions etc. can purchase their requirement of wooden furniture (Teakwood, Anjiliwood & Hardwood) directly from M/s Kerala Artisans Development Corporation Ltd.(KADCO) at the rates not exceeding the selling price shown against each item as indicated above for a period of one year from 17-1-2009.
