ORDER

As per the Government Order read as 1st paper above, Government had issued orders for relaxation of para 57 (a) (ii) of Stores Purchase Manual, in order to enable Kerala Small Industries Development Corporation Limited (SIDCO) to supply wooden furniture directly to all Government Departments (except schools), without following tender formalities. Such relaxation was granted initially for a period of one year and extended thereafter and the last order issued in this regard is read as 2nd paper above.

The Managing Director, SIDCO, as per the letter read as 3rd paper above, has requested Government to include schools also under the purview of the Government Order read as 2nd paper above and thereby enable SIDCO to supply wooden furniture directly to schools also, without following tender formalities.

Government have examined the matter in detail and are pleased to issue orders for including schools under the purview of the Government Order read as 2nd paper above and thereby permit SIDCO to supply wooden furniture directly to schools also.

The Government Order read as 2nd paper above stands modified to this extent.
