ORDER

As per the Government Order read as first paper above sanction was accorded to M/s Kerala Small Industries Development Corporation Ltd(SIDCO) to avail the concession under para 57(a)(i) of the Stores Purchase Manual for the year 1998-1999 for the supply of items manufactured by them except on items available under state rate contract and Director General of Supplies and Disposals rate contract as a special case. As per Government Orders read as second to fifth papers and the Government Orders read as 7th , 9th and 10th papers above, Government have extended the said concession for a further period of one year each. The last extended period expired on 26.11.2008.


