ORDER

As per the provisions of Stores Purchase Manual, both administrative sanction and purchase sanction are required for the purchase of furniture even from Government source(s) even if the proposed purchase is within the financial delegation prescribed. But as per the note under article 123 of Kerala Financial Code, both administrative sanction and purchase sanction are not necessary in the matter of purchase of furniture from Government sources which is against the provisions of Article 123 (ii) of Kerala Financial Code in which it is clearly laid down that officers should purchase furniture upto the extent they have been empowered.

2. Government have examined the matter in detail and are pleased to clarify that both administrative and purchase sanctions are required for the purchase of furniture even from Government sources and even if it falls within the financial delegation.

3. The amendment to the note under article 123 of Kerala Financial Code Volume I will be issued separately.
