**ORDER**

Kerala State Rural Women's Electronics Industrial Co-operative Federation Ltd. (KERALA STATE RUTRONIX), a joint venture of Department of Electronics, Government of India, Kerala Khadi and Village Industries Board, Khadi and Village Industries Commission, established with the aim of empowering Rural Women for Electronics.

2. Managing Director, Kerala State Rutronix, as per the letter read 1st paper above has requested to accord permission to all Government Departments/Public Sector Undertakings/Local Self Government Institutions/Autonomous Bodies/Quasi Government Undertakings for direct purchasing of electrical and solar items without observing quotation/tender formalities by relaxing Stores Purchase Rules.

3. As per the Government Order read as 2nd above, Government have constituted a Price Fixation Committee for fixing the rate of electrical and solar items supplied by Kerala State Rutronix placing the Additional Secretary, Stores Purchase Department as Chairman and Managing Director, Kerala State Rutronix as Convenor. The Price Fixation Committee meeting held on 7-1-2016, fixed the rates of various electrical and solar products of Kerala State Rutronix.

4. Government have examined the matter in detail and are pleased to accord sanction to Kerala State Rural Women's Electronics Industrial Co-operative Federation Ltd. (Kerala State Rutronix) to supply electrical and solar products directly to various Government Departments/Public Sector Undertakings/Local Self Government Institutions/Autonomous bodies/Quasi Government Undertakings without observing quotation/tender formalities, invoking relaxation to para 9.23 of Stores Purchase Manual, from the date of issuance of this Government Order upto 31st March, 2017. The rates of the products in respect of Kerala State Rutronix, fixed by the Price Fixation Committee are also approved, considering the decisions arrived at the meeting held on 7-1-2016. The price list of items is appended to this Government Order.

5. All Government Departments/Public Sector Undertakings/Local Self Government Institutions/Autonomous Bodies/Quasi Government Undertakings can purchase electrical and solar products directly from Kerala State Rutronix as per their requirement, in relaxation to para 9.23 of the Stores Purchase Manual subject to the condition that after the expiry of this Government Order (ie. after 31-3-2017) the rate may be revised accordingly. The minimum warranty of the products supplied is



one year and the price of items should not exceed the selling price fixed by Government, which is shown in the annexure to this Government Order. The Purchasing Officer should take care that the period of validity of the said relaxation is in force at the time of purchase.
