ORDER

As per the Government Order read 1<sup>st</sup> above, sanction was accorded to M/s. Kerala Artisans Development Corporation Ltd. (KADCO), Thiruvananthapuram to supply Steel furniture directly to all Government Departments, Public Sector Undertakings, Local Self Government Institutions, Autonomous Bodies etc. for a period of one year, without following tender formalities in relaxation to para 57 (a) (ii) of Stores Purchase Manual (para 9.23 of Revised Stores Purchase Manual). Thereafter, Government have extended the period of validity of the said Government Order, year after year and the latest extension was granted vide Government Order read 2<sup>nd</sup> above; and the validity of the same expired on 30/09/2016.

The firm submitted a proposal for revising and re-fixing the price of wooden and steel furniture supplying directly by them to different institutions without undergoing tender process earlier and subsequently, a Price fixation Committee has constituted in this regard vide Government Order read 3<sup>rd</sup> above.

Now, the Managing Director, M/s. Kerala Artisans Development Corporation Ltd. (KADCO), Thiruvananthapuram as per the letter read above has requested Government to extend the period of validity of the above said relaxation for a further

period of one more year with effect from 01/10/2016, since the validity expired on 30/09/2016.

Government have examined the matter in detail and are pleased to extend the period of validity of relaxation to para 9.23 of the Revised Stores Purchase Manual for a period of one more year with effect from 01/10/2016 or until the price are revised whichever is earlier, so as to enable M/s. Kerala Artisans Development Corporation Ltd. (KADCO) to supply steel furniture directly to all Government Departments/Public Sector Undertakings/Local Self Government Institutions/Autonomous Bodies etc. without following tender formalities, subject to the condition that the price of the items should not exceed to that shown in the approved price list, vide Government Order read 2<sup>nd</sup> above, which is annexed to this Government Order.

All Government Departments/Public Sector Undertakings/Local Self Government Institutions/Autonomous Bodies etc. can purchase steel furniture directly from M/s. Kerala Artisans Development Corporation Ltd. (KADCO), Thiruvananthapuram as per their requirement, without observing tender formalities, at the rates not exceeding the selling price shown against each item as indicated above, for a period of one more year with effect from 01/10/2016, until it is revised.
