ORDER

As per the G. O. read as 1st paper above, sanction had accorded to all Government Departments/Public Sector Undertakings/Local Self Government Institutions/Autonomous Bodies etc. to effect direct purchase of textile goods for their requirement from M/s Hanveev without resorting to tender formalities in relaxation of para 57(a) (i) of Stores Purchase Manual till 31-3-2006. Later the period of validity of the said relaxation had been extended by Government from time to time and the last extension was sanctioned vide G. O. read as 2nd paper above.

As per letter read as 3rd above, The Managing Director, M/s Hanveev has requested Government to extend the period of validity of the aforesaid relaxation with effect from 18-6-2020 since the same has been expired on 17-6-2020.

Government have examined the matter in detail and are pleased to extend the period of validity of relaxation for a further period of one more year with effect from 18-6-21020 so as to enable all Government Departments/Public Sector Undertakings/Local Self Government Institutions/ Autonomous Bodies etc. to purchase Textile Goods as per their requirement directly from M/s Hanveev without observing tender formalities, by relaxing para 9.23 of the Revised Stores Purchase Manual on the condition that time bound action must be initiated by the Managing Director, M/s Hanveev by furnishing proposal to Government for fixing the price of textile products to be supplied at a reasonable level. The Purchasing Officer should ensure that the period of validity of relaxation referred above is in force, while purchasing Textile Goods made from M/s Hanveev.
