**ORDER**

As per the Government Order read 1<sup>st</sup> above, sanction was accorded to all Government Departments/Public Sector Undertakings/Local Self Government Institutions/Autonomous Bodies etc. to effect direct purchase of Textile Goods from M/s. Hantex and M/s. Hanveev, without resorting to tender formalities in relaxation to para 57(a)(ii) of Stores Purchase Manual till 31/03/2006. Later, the period of validity of the said relaxation has been extended upto 27/11/2013 vide Government Order read 2<sup>nd</sup> above, on condition that further extension of period of validity will be granted only after fixing the price of Textile Goods by the Price Fixation Committee, constituted by Government.

Subsequently, a Price Fixation Committee was constituted as per Government Order 3<sup>rd</sup> above for fixing the price of Textile Goods supplied by M/s. Hantex and M/s. Hanveev to Government Departments/Public Sector Undertakings/Local Self Government Institutions/Autonomous Bodies etc., without following tender formalities.

Meanwhile, the Managing Director, M/s. Hantex vide letter read above has requested Government to exempt the Textile Goods supplied by the firm from price fixation since the price of raw materials like thread, dye and chemicals are fluctuating monthly and heavy trade loss will be happened to M/s. Hantex and M/s. Hanveev, if the price are fixed. He also requested to extend the period of validity of relaxation for direct supply of Textile Goods by the above firms to various institutions without tender formalities.

Government have examined the matter in detail and are pleased to extend the period of validity of relaxation to para 9.23 of revised Stores Purchase Manual so as to enable all Government Departments/Public Sector Undertakings/Local Self Government Institutions/Autonomous Bodies etc. to purchase Textile Goods as per their requirement directly from M/s. Hantex and M/s. Hanveev without observing tender formalities, for a further period of one more year with effect from the date of this order or until the price are fixed by the Price Fixation Committee already constituted, whichever is earlier. They should ensure that the period of validity of relaxation referred above is in force, while purchasing Textile Goods from M/s. Hantex and M/s. Hanveev.
