ORDER

As per Government Order read as first above, sanction was accorded to all Government Departments/Public Sector Undertakings/Autonomous Bodies, etc. in Kerala to place orders for purchase of Handicraft items, souvenirs and mementos exclusively from the showrooms of Handicrafts Development Corporation of Kerala Ltd. (HDCK), without inviting quotations, up to a financial limit of ₹ 10,000 in relaxation of Stores Purchase Rules.

The Managing Director, Handicrafts Development Corporation of Kerala Ltd., vide letter read above has requested to accord permission to all Government Departments/Public Sector Undertakings/Local Self Government Institutions/Autonomous Bodies and Quasi Government Undertakings for direct purchase of handicraft items, souvenirs and mementos without observing quotation/tender formalities by relaxing Stores Purchase Rules.

Considering the request, as per the Government Order read as third above, Government have constituted a Price Fixation Committee for fixing the rates of handicraft items, souvenirs and mementos supplied by Handicrafts Development Corporation of Kerala Ltd., placing the Joint Secretary, Stores Purchase Department as Chairman and the Managing Director, Handicrafts Development Corporation of Kerala Ltd. as the Convener. The Price Fixation Committee meeting held on 27-6-2014, fixed the rates of various products of Handicrafts Development Corporation of Kerala Ltd.

Government have examined the matter in detail and are pleased to accord sanction to Handicrafts Development Corporation of Kerala Ltd. to supply Handicraft items, souvenirs and mementos directly to various Government Departments/Public Sector Undertakings/Local Self Government Institutions/Autonomous Bodies and Quasi Government Undertakings, without observing tender formalities, invoking relaxation to para 9.23 of Stores Purchase Manual, for a period of two years from the date of issuance of this Government Order. The rates of the products in respect of Handicrafts Development Corporation of Kerala Ltd. fixed by the Price Fixation Committee are also approved, considering the decisions arrived at the meeting held on 27-6-2014. The price list of items is appended to this Government Order.

All Government Departments/Public Sector Undertakings/Local Self Government Institutions/Autonomous Bodies and Quasi Government Undertakings can purchase Handicraft items, souvenirs and mementos directly from Handicrafts Development Corporation of Kerala Ltd. as per their requirement, in relaxation to para 9.23 of the Stores Purchase Manual subject to the condition that the price of items should not exceed the selling price fixed by Government, which is shown in the annexure of this Government Order. The Purchasing Officer should take care that the period of validity of the said relaxation is in force at the time of purchase.
