## ORDER

As per the representations from various employees organizations of Kerala State Electronics Development Corporation Limited (KELTRON) and letter from the Managing Director, KELTRON read as 1st and 2nd papers above it has requested Government to entrust KELTRON for the supply of equipments and devices for the use of physically disabled persons and its distribution through the Local Self Government Institutions without Tender formalities under the purview of exemption from para 57 a (ii) of Stores Purchase Manual.

- 2) Accordingly Government have constituted a Price Fixation Committee, as per the Government Order read as 3<sup>rd</sup> paper above. The Price Fixation Committee, which met on 19-02-2009 have fixed the price of the equipments and devices for the use of physically disabled persons and its distribution through the Local Self Government Institutions, without following the Tender formalities.
- Government have examined the matter in detail and are pleased to order as follows: -
  - 1) Kerala State Electronics Development Corporation Limited (KELTRON) is entrusted with the supply of equipments and devices for the use of disabled persons for distribution through

Local Self Government Institutions without Tender formalities, in relaxation of para 57 a (ii) of Stores Purchase Manual for a period of one year from the date of issuance of this Government order.

- 2) The Price fixed by the Price Fixation Committee in respect of the equipments and devices for the use of disabled persons, supplied by KELTRON and the distribution through Local Self Government Institutions without Tender formalities, are approved. The approved price list is appended as Annexure to this Government Order.
- 3) This Price will be in force from the date of this order.
- 4) For items not included in the list, quotations / tenders ( as per Stores Purchase Manual ) are to be invited. KELTRON can also participate in those tenders.
