## **ORDER**

As per the Government Order read as first paper above orders were issued to the effect that all Government Departments(except Schools) will purchase their requirement of all types of wooden furniture from Kerala Small Industries Development Corporation Ltd(SIDCQ) without tender for a period of one year in relaxation of para 57(a)(i) of the Stores Purchase Manual. As per Government Orders read as second to 15th papers and the Government Order read as 17th ,19th and 20th papers above, the validity of the Government Order read as first paper above extended for a period of one year each. The last extended period vide G.O(Rt)No.46/2007/SPD dt.23.11.2007 expired on 19.11.2008.

The Managing Director in his letter read as 21st paper above, has requested Government to extend the period of validity of the above concession for a further period of two more years from 20.11.2008.

Government have examined the matter in detail and are pleased to extend the validity of the Government Order read as 1st paper above for a

further period of one more year from 20.11.2008 subject to the condition that the prices will be the same as appended to the Government Order(Rt)No.8/2006/SPD dt.7.2.2006, until it is revised.
