ORDER

The Managing Director, TRACO Cable Company, Kochi as per the letter read above, has requested Government to permit them to supply Building (House) Wiring Cables to Local Bodies, Autonomous Institutions, Public Sector Undertakings etc., without following tender formalities. The company is a registered firm in Stores Purchase Department vide Registration No. S. 2466/11/M/SSI/1/SPD dated 24-5-2011.

The Managing Director has reported that due to acute shortage of order from Kerala State Electricity Board, TRACO is facing severe financial loss as TRACO's major order shares are from Kerala State Electricity Board only for the ACSR Conductors. It is also informed that they have good capacity to manufacture and supply Building (House) Wiring Cables and stated that it would be of immense help to the company in its operation, to make use of the idling capacity if the Government could issue an order/circular to all Local Bodies/

Autonomous Institutions and Public Sector Undertakings for the purchase of Building (House) Wiring Cables from TRACO directly, i.e., without following tender formalities in relaxation of Stores Purchase Manual para 57 a (ii).

Government have examined the matter in detail and are pleased to order that all Government Departments/Local Bodies/Autonomous Institutions and Public Sector Undertakings can purchase Building (House) Wiring Cables directly from TRACO Cable Company, Kochi without following tender formalities in relaxation of para 57 a (ii) of Stores Purchase Manual for a period of one year from the date of issuance of this Government Order.
