**ORDER**

As per the Government Order read 1st paper above, sanction was accorded to all Government Departments/Public Sector Undertakings etc., to effect direct purchase of textile goods from M/s Hantex and M/s Hanveev, without resorting to tender formalities in relaxation of Para 57 (a) (ii) of stores Purchase Manual till 31-3-2006. Later the period of validity of the said relaxation had been extended up to 27-11-2012.

A Price Fixation committee was constituted as per the Government Order read 2nd above for fixing the price of textile goods supplied by M/s Hantex and M/s Hanveev to Government Departments/Public Sector Undertakings/Local Bodies/Autonomous Institutions etc., without following tender formalities with strict condition that extension of period of validity of the said relaxation would be considered only after fixing the price of the textile goods by the Price Fixation Committee.

As the period of validity vide the Government Order read 3rd above expired on 27-11-2012, the Industries Department has recommended to extend the period of validity of relaxation of Para 57 (a) (ii) of stores Purchase Manual for a period of one year from 28-11-2012.

Government have examined the matter in detail and are pleased to accord sanction to all Government Departments/Public Sector Undertakings/Autonomous Bodies/Local Self Government Institutions etc., to effect direct purchase of textile goods directly from M/s Hantex and M/s Hanveev, without resorting to tender formalities, in relaxation of Para 57 (a) (ii) of stores Purchase Manual for a period of one year from 28-11-2012, on condition that further extension of period of validity will be granted only after fixing the price of the textile goods by the Price Fixation Committee, already constituted by Government.
