ORDER

As per the Government Order read 1st above Government had permitted M/s. Wayanad Handloom Powerloom & Multipurpose Industrial Co-operative Society Ltd. No. S. IND (W) 66 to supply Uniform items and Textile items through Local Self Government Institutions without following tender formalities in relaxation of Para 57 (a) (ii) of Stores Purchase Manual. Thereafter Government have extended the period of validity of such relaxation for a period of one year from 1-3-2012, vide orders read 2nd above.

As the period of validity of the said relaxation expired on 28-2-2013, the Secretary, Wayanad Handloom Powerloom & Multipurpose Industrial Co-operative Society Ltd. No. S. IND (W) 66 in his letter read 3rd above has requested Government to extend the period of validity of relaxation as per Para 57 (a) (ii) of Stores Purchase Manual.

Government have examined the matter in detail and are pleased to extend the period of validity of relaxation of Para 57 (a) (ii) of Stores Purchase Manual, for a further period of one year from 1-3-2013, so as to enable them to supply Uniform items and Textile items through Local Self Government Institutions without tender, subject to the condition that the price of the items should be in accordance with that fixed as per Government Order read 1st above.
