**ORDER**

As per the Government Order read first above it was ordered that in any order placed with KELTRON for the supply of Personal Computers (including servers) and related accessories, by a Government Department, Public Sector Undertaking, Autonomous Body, Local Self Government Institution without following the tender procedure, KELTRON can supply items not manufactured/assembled/produced by them up to a maximum of 50% of the value of the order. In cases where more than 50% by value of the order constitutes branded items and items not manufactured/produced by KELTRON open tender system will have to be followed. It was also ordered that whenever a Department approaches KELTRON for placing orders of computer related hardware and software, KELTRON shall furnish to them a copy of this Government Order. The responsibility for this shall be with KELTRON.

2. As per the Government Order read second above, a one time exemption of Government Order read 1st was granted to Finance Department for the Purchase of computers and connected equipments through KELTRON, Thiruvananthapuram at a total cost of ₹ 49,05,362 for implementation of e-office in Finance Department.

3. As per the Government Order read as 3rd above, a one time exemption of the Government Order read 1st was granted to Finance Department for the purchase of 32 Laptops from M/s. KELTRON, Thiruvananthapuram at a total cost of ₹ 11,50,000 for the officers of Finance Department for the implementation of e-office in Finance Department.

4. Now in connection with the implementation of e-office project in 17 Departments in Administrative Secretariat, Information Technology (IT Cell) Department has forwarded a proposal for one time exemption from the Government Order read 1st above for all purchases to be done through M/s. KELTRON, Thiruvananthapuram at a total cost of ₹ 87,90,980 (Rupees Eighty Seven Lakhs Ninety Thousand Nine Hundred and Eighty only).

5. Government have examined the matter in detail and are pleased to grant one time exemption from G. O. (P) No. 01/2006/SPD dated 2-2-2006 and accord sanction to Information Technology (IT Cell) Department for all purchases through M/s. KELTRON, Thiruvananthapuram at an approximate cost of ₹ 87,90,980 (Rupees Eighty Seven Lakhs Ninety Thousand Nine Hundred and Eighty only) for the implementation of e-office in 17 Departments in Administrative Secretariat on condition that the prices of the Stores to be supplied should be economical when compared to market prices of the items.
