### ORDER

As per the Government Order read 1st above, Government had permitted M/s. Steel Industries Kerala Limited (SILK), Thrissur to supply furniture directly to all Government Departments, Public Sector Undertakings, Local Self Government Institutions, Autonomous Bodies, etc., without following tender formalities, for a period of one year w.e.f. 6-12-2008, invoking relaxation to para 57 (a) (ii) of Stores Purchase Manual (para 9.23 of the revised Stores Purchase Manual). Thereafter Government had extended the period of validity of such relaxation from time to time and the last extension was given vide Government Order read 2nd above, for a period of one year w.e.f. 1-4-2013.

The Managing Director, Steel Industries Kerala Limited, as per the letter read above, has requested Government to extend validity period for a further period of two years w.e.f. 1-4-2014, since the same has expired on 31-3-2014.

Government have examined the matter in detail and are pleased to extend the period of validity of relaxation of para 9.23 of revised Stores Purchase Manual for a further period of one year from the date of issuance of this Government Order so as to enable Steel Industries Kerala Limited (SILK),



Thrissur to supply furniture directly to various Government Departments/Public Sector Undertakings/Local Self Government Institutions/Autonomous Bodies, etc., without tender formalities, as per their requirement, subject to the condition that the rates of items does not exceed as shown in the Annexure to the Government Order read first above.

All Government Departments, Public Sector Undertakings, Local Self Government Institutions, Autonomous Bodies, etc. can purchase their requirement of furniture directly from Steel Industrials Kerala Limited without following tender formalities for a period of one year from the date of issuance of Government Order in relaxation of para 9.23 of the Stores Purchase Manual, without exceeding the price fixed by the Government vide Government Order read first above, until it is revised.
