ORDER

As per the Government Order read 1st above, Government had issued orders to the effect that all Government Departments, Public Sector Undertakings etc. would purchase their requirement of wooden furniture directly from M/s. Kerala Artisans Development Corporation Limited (KADCO), Thiruvananthapuram without following tender formalities for a period of one year in relaxation of Para 57(a)(ii) of Stores Purchase Manual (para 9.23 of the Revised Stores Purchase Manual). Later Government have extended the period of validity of the said Government Order, from year after year. The last period of extension granted vide the Government Order read as 3rd above expired on 16-1-2014.

The Managing Director, M/s Kerala Artisans Development Corporation Limited (KADCO), Thiruvananthapuram as per the letter read 4th above has requested Government to extend the period of validity for relaxation of Para 57(a)(ii) of Stores Purchase Manual for a further period of two years from 17/01/2014.

Government have examined the matter in detail and are pleased to extend the period of validity of relaxation of Para 9.23 of the Revised Stores Purchase Manual for a period of one more year with effect from 17-1-2014, subject to the condition that the price of the wooden furniture (Teak Wood, Anjili Wood & Hardwood) should be in accordance with the price list approved vide Government Order read as 2nd paperabove, until it is revised. Managing Director, KADCO will make arrangement to ensure the quality of the item supplied by the firm.

All Government Departments, Public Sector Undertakings, Local Self Government Institutions, Autonomous Bodies, etc., can purchase their requirement of wooden furniture (Teak Wood, Anjili Wood & Hardwood) directly from Kerala Artisans Development Corporation Limited (KADCO), Thiruvananthapuram at the rates not exceeding the selling price shown against each item as indicated above, for a period of one more year with effect from 17-1-2014 without following tender formalities, until it is revised.
