Registration and renewal of registration on the list of approved suppliers to Government of Kerala under the Stores Purchase Manual is one of the identified services for which a scheme has now been adopted by the IT Mission in association with National Informatic Centre. The software service is provided free of cost by National Informatic Centre.

As per G.O. read as 2<sup>nd</sup> paper above Government had approved the process Re-engineering Requirements submitted by National Informatic Centre Kerala and as recommended by the Kerala State Information Technology Mission and sanction was accorded to Kerala State Information Technology Mission to issue work order to National Informatic Centre to configure and develop the services using 'Service Plus' Software (e-Service Delivery).

Government had many rounds of disussions with the officials of Kerala State Information Technology Mission and National Informatic Centre for making the process simple and user friendly. Government has also given

permission to Kerala State Information Technology Mission to conduct training those employees connected with Online Registration programme to process. Training has given to the officials of Stores Purchase Department of Secretariat, Directorate of Government **Industries** and Commerce, Thiruvananthapuram and 14 District Industries Centres.

In the above circumstancesGovernment are pleased to accord sanction to launch Online Registration and Renewal of Registration of Firms with Stores Purchase Department through Service Plus Software installed in the Government web site,i.e.,www.spd.kerala.gov.in w.e.f 27<sup>th</sup> April,2015.Application for Registration and Renewal of Registrationfrom 01.05.2015 will be accepted through online only.
