#### Abstract

Stores Purchase Department - Direct purchase of soap items from M/s Kerala Soaps, Kozhikode, a unit of Kerala State Industrial Enterprises Ltd without Tender formalities - Price Revision and Period of validity - Extended -Orders issued.

#### ORDER

As per the Government Order read first above, Government have permitted M/s Kerala Soaps, Kozhikode, a unit of Kerala State Industrial Enterprises Ltd to supply soap items directly to all Government Departments, Public Sector Undertakings, Local Self Government Institutions without following tender formalities for a period of one year from 28/12/2011 by relaxing para 57(a)(ii)of Stores Purchase Manual and accepting the price of soap items fixed by the Price Fixation Committee.

As per the GO read as 2<sup>nd</sup> above Government have accorded sanction to extend the period of validity for one year from 29.12.2012 on condition that the prices of soap items will be as fixed in the Government Order cited 1st above. The period of validity of the said Government Order, dated 8.2.2013 expired on 8.2.2014.

As per the Government Order read third above Government have accorded sanction to extend the period of validity of relaxation of Para 9.23 for a further period of one year from 29/12/2013 accepting the price of soap items including the two new itmes (Kerala Sandal and Trio pack of family pack) fixed by the price fixation committee since it is a reviving unit. The period of validity of the said order dated 19/4/2014 expired on 18/4/2015.

As per letter read fourth above, the Managing Director, Kerala State Industrial Enterprises (KSIE) Ltd, Thiruvananthapuram has requested for a further extension for a period of one more year from 19.4.2015 and to revise the price of nine soap items as it is extremely difficult to supply this soap items in the existing rate. The difference in price is for nine items. There is no other change in the case of new items compared to last year.

As per the Government Order read 5<sup>th</sup> above a Price Fixation Committee was formed and they have approved the new price of nine soap items in the list as proposed by the Kerala State Industrial Enterprises Ltd for the supply to Government Department, Public Sector Undertakings, Local Self Government Institutions without tender formalities. The selling price of soap items are exclusive of taxes, duties, loading and unloading and transportation charges.

Government have examined the matter in detail and are pleased to extend the period of validity of relaxation of Para 9.23 of Stores Purchase Manual for a further period of one year from 19.04.2015 accepting the price of soap items fixed by the price fixation committee since it is a reviving unit. (copy of the price of the soaps is enclosed as Annexure to this Government Order).

All Government Departments, Public Sector Undertakings, Local bodies, Autonomous Institutions etc should purchase soap items only from M/s Kerala Soaps, Kozhikode, a unit of Kerala State Industrial Enterprises Ltd till 18/04/2016 without exceeding the price fixed by the Price Fixation Committee.
