ORDER

As per the Government Order read 1st above, Government have permitted all Government Departments, Public Sector Undertakings, Local Self Government Institutions, Autonomous Bodies etc. to purchase processed rubber wood furniture and rubberised coir mattresses directly from M/s. Kerala State Rubber Co-operative Ltd.(RUBCO) in relaxation to para 57 (a) (ii) of Stores Purchase Manual for a period of 3 years with effect from 07-12-2006. Thereafter, Government have extended the period of validity of the said relaxation from time to time and the latest extension has done as per the Government Order read as 4th paper above.

As per the letter read above, the Managing Director, M/s. Kerala State Rubber Co-operative Ltd.(RUBCO) has requested to extend the period of validity of the Government Order read 4th above for a period of one more year with effect from 24.06.2018, since the same expired on 23/06/2018.

Government have examined the matter in detail and are pleased to extend the period of validity of relaxation to para 9.23 of the revised Stores Purchase Manual for a further period of one more year with effect from 24-06-2018, so as to enable M/s.Kerala State Rubber Co-operative Ltd. (RUBCO) to supply wooden furniture directly to all Government Departments, Public Sector undertakings, Local Self Government Institutions, Autonomous Bodies etc. without observing tender formalities subject to the condition that the price of items does not exceed the selling price shown in

the Annexure of the Government Order read 4th above. The relaxation will only be applicable to items manufactured by RUBCO.

All Government Departments/Public Sector Undertakings/ Local Self Government Institutions, Autonomous Bodies etc. can purchase their requirements of wooden furniture directly from M/s. Kerala State Rubber Co-operative Ltd. (RUBCO) without following tender formalities, at the rates not exceeding the selling price shown against each item in the Annexure of the Government Order read as 4th above and the condition that the relaxation will only be applicable to items manufactured by RUBCO. The purchasing officers should ensure that the period of validity of relaxation to para 9.23 of Stores Purchase Manual is in force, at the time of purchase of the aforesaid items from M/s. RUBCO.
