**ORDER**

As per the Government Order read 1st above, sanction was accorded to all Government Departments/Public Sector Undertakings/Local Self Government Institutions/Autonomous Bodies etc. to effect direct purchase of Textile Goods from M/s Hantex and M/s Hanveev without resorting to tender formalities in relaxation to para 57(a) (ii) of Stores Purchase Manual till 31-3-2006. Thereafter the period of validity of the said relaxation has been extended by Government from time to time and the latest extension was done vide G. O. read as 4th paper above.

2. The Managing Director, M/s Hanveev vide letter read 5th above has requested Government to extend the period of validity of the aforesaid relaxation to the next one year with effect from 18-6-2019, since the same expired on 17-6-2019.

3. Government have examined the matter in detail and are pleased to extend the period of validity of relaxation for a further period of one more year with effect from 18-6-2019 so as to enable all Government Departments/Public Sector Undertakings/Local Self Government Institutions/Autonomous Bodies etc. to purchase Textile Goods as per their requirement directly from M/s Hanveev, without observing tender formalities, invoking para 9.23 of the Revised Stores Purchase Manual. Manufacturing for the above purpose does not include mere repackaging or rebranding of items but shall involve at least 25% value addition. The Purchasing Officer should ensure that the period of validity of relaxation referred above is in force, while purchasing Textile Goods made from M/s Hanveev.
