Stores Purchase Department - M/S Meenachil Rubberwood Ltd., Kottayam - Direct purchase of processed Rubberwood furniture and office furniture by various Government Departments/Public Sector Under takings/Local Self Government Institutions/Autonomous Bodies etc. from Meenachil Rubberwood Ltd. without tender formalities - period of validity extended - orders issued.

ORDER

As per Government Order read 2nd above, sanction was accorded to M/s Meenachil Rubberwood Ltd., Kottayam to supply processed rubberwood furniture and office furniture directly to all Government Departments/Public Sector Undertakings/Local Self Government Institutions/Autonomous Bodies etc. without following tender formalities in relaxation to para 9.23 of the revised Stores Purchase Manual for a period of one year with effect from 27.04.2018 to 26.04.2019. The Managing Director, M/s Meenachil Rubberwood in his letter read above has requested to extend the period of validity for a further period of one year with effect from 27.04.2019.

- 2. Government have examined the matter in detail and are pleased to extend the period of validity of relaxation of para 9.23 of the Revised Stores Purchase Manual for a further period of one more year with effect from 27.04.2019, so as to enable M/s Meenachil Rubberwood Ltd. to supply processed rubberwood furniture and office furniture directly to all Government Departments/Public Sector Undertakings/Local Self Institutions/Autonomous Bodies etc. subject to the condition that the price of items does not exceed the selling price fixed as per the Government Order read as 1st above. The said relaxation is applicable only for the items manufactured by the institution itself.
- 3. Manufacturing for the above purpose does not include mere repackaging or rebranding or merely assembly of items but shall involve at least 25% value addition.

All Government Departments/Public Sector Undertakings/Local Self Government Institutions/Autonomous Bodies etc. can purchase their requirements of processed rubberwood furniture and office furniture directly from M/s Meenachil Rubberwood Ltd. without following tender formalities, at the rates not exceeding the selling price shown against each item in the Annexure. They should also ensure that the period of validity of relaxation to para 9.23 of the Stores Purchase Manual is in force at the time of purchase of the aforesaid items from M/s Meenachil Rubberwood Ltd. and obtain a certificate from the MD of the institution stating that this item has been manufactured by them and not bought from outside.
