ORDER

As per Government Order read 1st above, sanction was accorded permitting all Government Departments/Public Sector Undertakings/Local Self Government Institutions/Autonomous Bodies etc. to purchase their requirement of Steel furniture items directly from M/s. Steel Industrials Kerala Ltd. (SILK), Thrissur without following tender formalities for a

period of one year w.e.f. 6-12-2008, by invoking relaxation to para 57(a) to (ii) of Stores Purchase Manual (para 9.23 of revised SPM) and the prices of the furniture items were fixed. Thereafter Government had extended the validity period of tender exemption from time to time and the last extension along with inclusion of new items and price revision was done as per Government Order cited 2nd above.

2. Now, the Managing Director, M/s. Steel Industrials Kerala Ltd. (SILK), Thrissur vide letter read 3rd above has requested to extend the validity period of tender relaxation for another two years w.e.f. 19-2-2022, since the same expired on 18-2-2022.

3. Government have examined the matter in detail and are pleased to extend the validity period of relaxation to para 9.23 of the Revised Stores Purchase Manual for a further period of one more year with effect from the date of issue of the Government Order so as to enable M/s. Steel Industrials Kerala Ltd. (SILK), Thrissur to supply steel furniture items directly to all Government Departments/Public Sector Undertakings/Local Self Government Institutions/Autonomous Bodies etc. without observing tender formalities, subject to the condition that the selling price of the items should not exceed to that fixed as per GO. cited 2nd above and the products should carry an indelible mark of the company along with a guarantee period for one year.

4. The Purchasing Officer should ensure that the validity period of relaxation to para 9.23 of Revised Stores Purchase Manual is in force at the time of purchase and for items not included in the price list, the other procurement modes as per Stores Purchase Rules shall be resorted to.
