ORDER

As per the Government Order read 1st above, sanction was accorded to M/s Wayanad Handloom Powerloom and Multipurpose Industrial Co-operative Society Ltd. No. S.IND(W) 66 to supply Uniform items and Textile items directly through Local Self Government Institutions without following tender formalities by invoking relaxation to para 57 (a) (ii) of Stores Purchase Manual (para 9.23 of the revised Stores Purchase Manual). Thereafter Government have extended the validity period of relaxation from time to time and the last extension was done as per Government Order read 2nd above, for a period of one year with effect from 15-8-2019.

(2) As per letter read 3rd above, the Director, Kerala State Co-operative Textile Federation Ltd. (TEXFED) has forwarded the proposal of M/s Wayanad Handloom Powerloom and Multipurpose Industrial Co-operative Society Ltd. No. S.IND(W) 66 to extend the validity of tender relaxation for a further period of two years, since the same expired on 14-8-2020.

(3) Government have examined the matter in detail and are pleased to accord sanction to M/s Wayanad Handloom Powerloom and Multipurpose Industrial Co-operative Society Ltd. No. S. IND(W) 66, to supply Uniform and Textile items manufactured by the society directly through Local Self Government Institutions as per their requirement without following tender formalities, by relaxing para 9.23 of the Stores Purchase Manual for a period of one year with effect from the date of issuance of this Government Order subject to the following conditions:

(a) Price of items should be in accordance with that fixed as per Government Order read 1st above.

(b) Director, Handloom and Textiles should ensure that the total supply of yarn and cloths supplied by this co-operative does not exceed their production.

(c) Marketing on the basis of this Order is not allowed after the expiry of the validity period of tender exemption.
