ORDER

As per the Government Order read first above, the Government had permitted M/s Steel Industrials Kerala Limited (SILK), Thrissur, to supply furniture directly to all Government Departments, Public Sector Undertakings, Local Self-Government Institutions, Autonomous Bodies, etc., without following tender formalities, for a period of one year, by granting a relaxation from Para 9.23 of the Stores Purchase Manual, along with the fixation of prices for 121 items. Thereafter, the Government extended the validity of the said relaxation from time to time, with the last extension granted as per the Government Order read second above, for a period of one year.

2. The Managing Director, Steel Industrials Kerala Limited (SILK), as per the letter read 3rd above, has requested the Government to extend the validity period of the tender relaxation for one more year, since the same

expired on 20.07.2023.

3. Government have examined the matter in detail and are pleased to extend the period of validity of the relaxation from Para 9.23 of the revised Stores Purchase Manual for a further period of one year from the date of issuance of this Government Order, so as to enable M/s Steel Industrials Kerala Limited (SILK), Thrissur, to supply furniture directly to various Government Departments, Public Sector Undertakings, Local Self-

Government Institutions, Autonomous Bodies, etc., without following tender formalities, for a period of one year with effect from the date of issue of this Order, subject to the following condition:

Marketing under the purview of this Order shall be permitted only for the firm's own products, and the selling price shall not exceed the rates fixed

vide the Order read 1st above.

4. The Purchasing Officer should ensure that the validity period of relaxation in Para 9.23 of the revised Stores Purchase Manual is in force at the time of purchase. For the purchase of items not included in the price list (as per the Order read 1st above), other procurement modes following the norms contained in the Stores Purchase Manual shall be resorted to.
