**ORDER**

As per the Government Order read 1st above, sanction had been accorded to M/s Wayanad Handloom Powerloom and Multipurpose Industrial Co-operative Society Ltd. No. S. IND (W) 66 to supply Uniform Items and Textile Items directly through Local Self Government Institutions without

following tender formalities, invoking relaxation to para 57 (a) (ii) of Stores Purchase Manual (para 9.23 of the revised Stores Purchase Manual). Thereafter, Government have extended the validity period of relaxation from time to time and the last extension was done vide Government Order read 2nd above, for a period of one year with effect from 14-8-2018.

2. M/s Wayanad Handloom Powerloom and Multipurpose Industrial Co-operative Society Ltd. No. S. IND (W) 66, vide representation read 3rd above has requested Government to extend the validity period of the above said relaxation, since the same has expired on 15-8-2019.

3. Government have examined the matter in detail and are pleased to extend the validity period of relaxation to para 9.23 of the Stores Purchase Manual for a further period of one more year with effect from 15-8-2019, so as to enable Wayanad Handloom Powerloom and Multipurpose Industrial Co-operative Society Ltd. No. S. IND (W) 66 to supply Uniform items and Textile items manufactured by the society directly through Local Self Government Institutions, as per their requirement without following, tender formalities, subject to the following conditions:

- (i) the price of items should be in accordance with that fixed as per Government Order read 1st above.
- (ii) Director, Handloom & Textiles should ensure that the total supply of yarn and clothes supplied by this co-operative does not exceed their production. For that a system would be put in place with the approval of Stores Purchase Dept. This should be verified in terms of wages being paid to workers and members to ensure that cloth bought from outside is not supplied under this system.
